Fran Fulton and Downtown Torrance business owners sat in on a meeting to observe how the meeting is run. Downtown Torrance is pursuing forming a Business Improvement District

1. Redondo Beach Police Dept (Kyle Lofstrum)

City of Redondo Beach code enforcement Jo Salcido was present at the meeting to discuss sidewalk encroachment of outdoor dining as well as sidewalk use for retail. The special event permit according to code enforcement does not include retail. Kathleen will look for the permit for details related to sidewalk use by retail and contact Ted Semaan.

Ralph brought up the abrupt way in which code enforcement police officers approached restaurants with no prior warning of their visit. Allen suggested providing the RVA Board with a heads up next time they are enforcing in order for the BOD to alert businesses. Restaurants on the prior list of outdoor dining will be approached. If the RVA knows of restaurants that no longer use the sidewalk, please let them know so the list will be adjusted. Regarding the sidewalk paver program businesses will get five year concessions for sidewalk improvements.

Two officers are assigned to the holiday stroll. RBPD reiterated there will be more police on foot patrol in Riviera Village and available to answer questions of any businesses that approach them. Additionally, the police department has purchased a few E bikes for officers to address the "E bikes war".

a. Holiday Stroll

95% of attractions and vendors are confirmed. \$69,000 has been spent thus far. City will rebate \$2500 for permit fees. The carousel will be moved into place at 9 AM on December 1 and that portion of the street will be closed until 3 AM. 3 Leaf Realty will have a "school of rock" band as an attraction in front of their real estate office. 3 Leaf Realty will subsidize this.

Holiday stroll sponsorships. Allen proposed offering two sponsorships with a buy-in of \$2500. One for the carousel two for photo booths. This is a pilot program and will be considered as part of the Stroll in 2023. Sponsorship will be communicated with a 3' x 4' sign and the use of the name/holiday stroll logo along with the sponsor name and logo. Ralph suggested sharing this opportunity with Pacific Premier Bank. The bank is an RVA member. Nils will confirm for December2022 meeting if the cost of mid- term Parklets renovation is covered by the city A parking study took place over a two day period that found the heaviest parking occurred weekdays at 1 PM Parking mitigation:

- Nils is proposing a metered parking fee of two dollars per hour on Catalina to motivate people to park in the triangle parking lot.
- The City Council discussed closing off the entrance to the triangle parking lot from Via Valencia/S Elena. This would add 15 more spots. The city would/will test this option with bollards.
- Lessen the number of "orange" spots for employees.

- Need to manage parking spaces more efficiently.
- Permit buying online for parking has been proposed.
- Add to agenda ongoing discussion items for parking enforcement and private parking enforcement paid for by Riviera Village.
