V. PRESIDENT'S REPORT

- 1. Seaside Ice: Thursday is 80's night visit seasideice.com for details.
- 2. Village Capital Improvement update Veronica Wolkow & Bill Workman: Bill said sidewalks & signage are great looking improvements for the Riviera Village (contrary to the UU opposition). He said about 100k is ear marked for additional Riviera Village improvement as well as about 50k left over from the other improvements and a new entry sign at PV Blvd/Catalina is the next sign he suggests the sign goes. Bill will work with Jeff G on trying to get an easement to install a sign in the planter of the service station. Bill is looking to a few locations for more paving stones; Cris B said the stones need to be sealed as the stones which are not sealed absorb coffee, grease, etc stains and look bad once stained. Bill said new rubbish contract includes steam cleaning sidewalks. Ron Z, Cari C made motion to consider 1900 block (alley to north) for next paver stone improvement project MSA20091116-02 (Cris & Keith abstained). Cari C, Mike W made motion to request city investigate changing the grassy area in front of Wells Fargo on Elena into parking spots <u>MSA20091116-03</u>. Ron Z, Chad S made motion to have city install next entryway "gateway" signage to go at Catalina Avenue & Palos Verdes Boulevard (be the sign to reflect it is the main gateway to the village) <u>MSA20091116-04</u>.
- 3. Annual BID renewal reports due: Veronica W has reports she needs and said tomorrow will be the first reading; things should go smoothly and anybody wanting to be present is welcome to be there.
- 4. Electric car update Jeff G: Pizza and other restaurant delivery service is perfect opportunity for this program; Ron Z met with Wally about Pedone's using the vehicle to do deliveries. More information to follow.
- RFQ review for painting vents in Village: Mike M said monies were previously allocated for the paint supplies, etc by the BID but we need to send a RFQ to the Public Arts Commission to get the project officially out to the artists. Jeff G, Ron Z made motion to create a Edison Vents committee to generate the RFQ for this project <u>MSA20091116-05</u>.

Cari C & Mike W said weekly newspapers make a lot more sense than Daily Breeze and budget should be allocated accordingly.
