 - City Update James Allen: sidewalk power wash is setup on quarterly basis. Reminded us that we need to renew BID with City Council soon so financials, etc will be needed.

 - Farmers Market Susan Hillyer/Ellen said all went well (health/fire department, etc); vendors happy with venue, this Friday the non-agriculture vendors are being added to the market. They want to do an official "Grand Opening" in October and banners are being ordered for the entryway signs.
