IV. PRESIDENT'S REPORT:

- 1. ARTscape is coming up. Look for it.
- Farmers Market Ellen: the market needs advertising. Ellen will get to work on this. Mike W: Have we made any money? Have
 not received any payment. Mike W asked Jim Allen to check on check. Ellen: Brendan Collins is Chef this week. He promoted the
 Market by featuring all products used from the RV Farmers Market.

VII. Action Items

Jenny talked about the new KFWB proposal. RB Visitors Bureau has put in \$15K, and is asking individual groups to put in \$2,500 each to make up the next \$15K to secure the whole day.

We would get ten 60-second radio spots, banner ads as KFWB month-long promotion on the radio stations. Redondo Beach is secured as the afternoon destination. Mike W, Ron Z made motion NTE \$2,500 towards "KFWB on the corner" radio marketing promotion of the village MSA_20110719-03

VIII. Committee Reports

- 1. Jim Allen Mike M asked about dates for next capital improvement project in the Village. Jim reported that things are slowing down after the Esplanade project.
 - Mike W asked about food trucks. Jim said it's in the City Attorneys office.
- 2. Mike W Summer Festival was good, beer garden 40% up, carnival up 30%, 214 booths. Ron Z asked about booth prices. Mike W said they'd be raised to \$400 next year. Mike W said BID would get check for \$37,000 this year, up from \$31,000 from last year. Pascha thought it was the best Festival he's been to –good bands. Ron Z agreed that the bar has been raised. Bike valet went well for the first year. Mike W wants to add a North shuttle, say from Mira Costa, or West High.

Ellen E – Terranea Resort shuttle – we'll be having a meeting this week to firm everything up. Ron Z said to go ahead with the walking map. Ellen talked about the KCAL opportunity: \$3800 for a 3-minute spot that will air on KCAL on Friday at 6:30 am. Ellen suggested that it could be used to air in the rooms at Terranea. Ellen said that she would get a written proposal from KCAL and talk about it more at the next BID meeting.

Other business – Mike W said that we need to resurrect the RVA as the non-profit arm of the RV-BID. We pay Del Aire money every month for the Farmers Market because the RVA doesn't have their non-profit status together. We need to talk to the insurance company to find out how best to do this. There was discussion about who would be members, should they have to pay? Mike W says there needs to be a meeting to figure all this out. Mike M said that he would set this up. Terry said that we need to look through the bylaws and see what can be done.

Ron Z asked about Holiday Stroll. Ellen said that we're meeting on this Thursday.

Ellen E (BID Marketing Director) said recently she worked out details with the Terranea Shuttle service (Palo) where for \$12.00 a trip they would shuttle guests to the Riviera Village; Mike Ward suggested the shuttle drop off guests at the Kiosk since it is pretty much in the center of the Riviera Village. Ron Z, Jeff G made motion to have Ellen E and Jeff G negotiate with Terranea Shuttle Service to pay NTE \$12 per trip and NTE \$1000 per month to shuttle Terranea guests to the Kiosk and set this up ASAP MSA20110707-02
 - d. Jeff G said he will be in Washington DC on a family vacation the next BID meeting date of 7/19/2011 and Ellen E agreed to take minutes for that next meeting.
